- The March 27, 2020 distribution was for \$0.66 per share on 45,698,151 shares.**
- The June 5, 2020 distribution was for \$0.68 per share on 45,731,823 shares.**
- The September 4, 2020 distribution was for \$0.705 per share on 45,838,508 shares.**
- The December 4, 2020 distribution was for \$0.73 per share on 45,826,904 shares.**

**The Company had no Accumulated Earnings and Profits ("E&P") at the beginning of 2020 and had \$46,822,532 of current E&P as of December 31, 2020.**

**36.86% of each of the four 2020 distributions is classified as a dividend.**  
**63.14% of each of the four 2020 distributions is classified as a non-taxable return of capital.**
